If any services such as private tuition, speech & language therapy or personal assistants are required, the school reserves the right to refuse admission on the grounds of not having adequate resources or levy these extra services at the sole expense of the parents. Creative Kids International Preschool are designed to be academically and developmentally appropriate exclusively make decisions with respect to initial class placement.

Creative Kids International Preschool may refuse admission on the grounds of any of the following:

1. The student's best interests are needs cannot be met.

2. Tuition is due no later than the 25th of each month.

2. Lunch

1. The lunch fee will be added to the monthly fee for a one lump payment each month.
2. There are no refunds for the lunch fee.
